Individuals submit their T1163 or T2042 from 2007 - 2012 with this form. Corporations, trusts and special individuals submit their Statement A from 2007 - 2012 with this form. Current AgriStability participants re-applying as a new business structure (e.g., individual who has incorporated) are not required to submit tax forms.

The deadline to submit this form and supporting documentation is April 30, 2013.

Once enrolled in AgriStability, individuals must submit a T1163 to Canada Revenue Agency by June 15 each year. Corporations, trusts and special individuals must submit their Statement A to Agricorp by June 30 each year. Agreement and signature

I agree to:

- Abide by all terms, conditions and procedures of the AgriStability program as set out in the AgriStability Program Guidelines (available on agricorp.com).

- Provide accurate, timely and full information to Agricorp when requested, and notify Agricorp in the event that there are any changes to information I have provided on this form or to the Canada Revenue Agency.

I certify that:

- All information submitted on this application is accurate and true.
- I have not purposely altered my farm's ownership, business structure, size of operation, farming practices, type of farming activity, accounting methods or any other activity or practice, in order to be eligible for, or to increase an AgriStability benefit.
- I have included details on all farming activities that I am involved in (e.g., sole proprietorships, partnerships, corporations). The information provided is complete and correct and may be confirmed with the Canada Revenue Agency.
- My main farmstead is in Ontario. Any farming activities conducted by me outside of Ontario have been disclosed on this form.
- I am actively involved in carrying out the physical work needed to produce and market agricultural commodities, or actively participating in a wide variety of day to day management decisions required for the ongoing operation of the farm enterprise.
- I have or will be reporting farming income to the Canada Revenue Agency for the program year.
- I have conducted a minimum of six consecutive months of farming activity and completed a production cycle in the program year.
- I have provided information on any non- arm's length farming relationship in which I am involved, including any involving business transactions that fall below or exceed what would be considered fair market value or barter.
- I have followed the AgriStability Program Guidelines when completing these forms and have provided full and accurate information.

I consent to:

- Agricorp's access to the Canada Revenue Agency, Net Income Stabilization Account (NISA), and/or previous Ontario Whole Farm Relief Program (OWFRP), Ontario Farm Income Disaster Program (OFIDP), Canadian Agricultural Income Stabilization (CAIS) Program, Production Insurance (PI), Risk Management Program (RMP), Market Revenue program information and information from other federal/provincial programs related to my farming activities. This information may be used specifically to verify the information provided in this AgriStability application or during any audit.
- Agricorp's access to, and the use of, NISA and/or previous OWFRP, CAIS, PI and OFIDP information to determine my reference margin and program year margin. Other NISA information may be used specifically to verify the information provided in this AgriStability application or during any audit.

I understand and acknowledge that:

- Separate AgriStability information may be required for all activities in which all individuals, partners and shareholders are involved in order for this application to be considered for AgriStability benefits.
- Any funds payable to me under this program may be subject to recovery or offset against any pre-existing debts I may have to the Crown in right of Ontario or Canada.
- I will incur an administrative cost share (ACS) of \$55 per program year to cover part of the program's administrative costs.
- I may be required to provide Agricorp access to information held directly by third parties including, but not limited to, insurance companies, banks, trust companies, other financial institutions, and marketing boards, and I will execute any consent or similar forms any third party may require before providing Agricorp such access.
- In addition to its use in AgriStability, agricultural production and contact information collected in this application may also be used by provincial, federal, or municipal government authorities for the purpose of emergency management. Emergency management includes planning, activities and programs for preventing, preparing for, responding to, and recovering from emergencies.
- Further farm income tax records relating to the reference or program years may be required as part of an audit for further verification. AgriStability and income tax records must be consistent in order for the participant to be eligible for AgriStability. I will retain farm financial and production records relating to this application for 10 (ten) years.
- Information on the AgriStability forms and in supporting documents is collected by Agricorp to administer AgriStability under the Federal/Provincial Growing Forward 2 Agreement as amended, or any subsequent Federal/Provincial Agreement.
- If I provide any information that is false or misleading in this form or supporting documents, I may be required to repay any AgriStability benefits I have received for this program year, and may be deemed ineligible to participate in the AgriStability program for up to two additional program years.
- If it is determined that I have received benefits beyond the amount I am entitled to in the program year, or in contravention of any program requirements, the obligations set out in this application, or the laws of Ontario or Canada, such amounts (overpayments) will be debts due and payable to the Crown in right of Ontario or Canada, and I will be required to return all or part of the funds received, as determined by Agricorp. Overpayments may be offset from payments I may be eligible to under this or any other program administered or delivered by Agricorp, other federal or provincial programs, or federal or provincial tax programs. Information collected in this application may be used by Agricorp or shared provincial or federal ministries or agencies for the purpose of recovering overpayments.
