

# Income Exemption for Age, Illness or Death of Spouse Farm Property Class Tax Rate Program

Property tax year: **2024**

*If your gross farm income in 2022 was less than \$7,000 due to age, illness (including injury) or the death of your spouse, you may apply for an exemption from the requirement to provide a Farm Business Registration number. To be eligible for this exemption, you must meet the following criteria:*

- You carry on the farm business yourself.
- You or your spouse have operated the farm business on the properties listed on this form for at least the past 10 years.
- The properties listed on this form were taxed at the farm property class tax rate for at least the past 10 years.
- The farm business reported a gross farm income greater than zero in 2022.

*For new income exemption applications, complete **Section B**. For expired income exemptions, complete **Section C**.*

Submitting false or misleading information in this form could result in the denial of this request and any potential future requests that could be made by myself, myself on behalf of another person, or another person affiliated with myself in any type of farming business relationship in which this request is being made under the *Assessment Act*, or require that any exemptions received as a result of the submission of false or misleading information be revoked and that any monetary payments received as a result of the exemption may have to be repaid.
5. The information contained in this document or submitted to Agricornp in connection with the program, or under other programs administered by Agricornp or the Ontario Ministry of Agriculture, Food and Rural Affairs (OMAFRA), may be shared between Agricornp and any government department, ministry or agency, the Municipal Property Assessment Corporation, and municipalities for the purposes of administering, auditing and evaluating the program.
